Instructions:

- 1. Kindly bring all photocopies along with the admission form.
- 2. Fill all the entries of admission form correctly & neatly as per the T.C. record of previous School.
- 3. Fee will be Charged Quarterly in advance in the months of April, July, October & January.
- 4. Fee once deposited will not be refunded in any case.
- 5. The last date to deposit the fee is the 10th of each of the above months, failing which a fine will be charged.
- 6. Cheque/DD returned by the bank for any reason what so ever shall be treated as non-payment of dues and additional Rs. 500/-shall be charged along with late fine.
- $7. \quad \text{Previous school documents should be submitted within 15 days from the date of admission failing which the direct admission will be considered as cancelled.}$

- 9. Corporate discount will be Rs. 5000 (one time) for Maruti, Honda, Minda and Hero Group.
- 10. Sibling discount
 - (A) There will be 20% discount of monthly composite fee, in case of 2nd child. (Child: A(full), Child: B (20% discount)
 - (B) There will be 75% discount of monthly composite fee, in case of 3rd child.

(Child: A (full), Child: B (full), Child C (75% discount of monthly composite fee).

REFUND POLICY

- 1. If a student withdraws his candidature before the start of the session then all the money will be refunded except the Admission fees.
- 2. If a student withdraws his candidature before the start of the session and he/she had submitted Caution Money only then also an amount of Rs10000 will be deducted.
- 3. If a student withdraws his candidature after the start of the session then all the money will be forfeited except Caution Money i.e. Only Caution Money will be refunded.

WITHDRAWALS

- One year calendar months' notice in writing or a month's fees in lieu of such notice must be given before a student can be withdrawn.
- Those who leave the school in May must in all cases pay the fees for the month of June.
- Transfer certificates are not issued until all dues of the school are settled.
- Students can be asked to leave the school on the following grounds:
 - 1. Disciplinary
 - 2. Unsatisfactory progress in academics.
 - 3. Detention or repeated detention in a class. As a rule, only those students will be retained on the rolls of this school who can take the school leaving examination and are under 18 years of age.
 - 4. A student who fails twice in the same class will not be permitted to continue his/her studies in the school especially if he/she is below average in that class. Where a withdrawal takes place due to the above reasons, the question of charging a month's fee in lieu of notice does not arise.
- A student who is admitted to the school and all admission formalities are complete is only refunded the caution fee if he/she wants to withdraw from the school.
